Elec & Eltek International Company Limited (the "Company") allotted and issued 6,953,000 ordinary shares pursuant to the exercise of share options granted under The 2002 Elec & Eltek Employees' Share Option Scheme at a subscription price of US\$2.033 per share. The new shares allotted comprises of 5,493,200 scripless shares and 1,459,800 scrip shares at 486,600 shares per share certificate.

The deemed interest of Mr. Chan Wing Kwan of 566,600 shares are held through the following registered shareholders:

- (1) OCBC Securities Private Ltd. - 50,000 shares; and
- (2) HSBC Broking Securities (Asia) Ltd - 516,600 shares.

The percentage of issued share capital in respect of shares before the change is calculated based on 178,887,062 issued ordinary shares of the Company excluding treasury shares.

The percentage of issued share capital in respect of shares which are the subject of this notice and after the change is calculated based on 184,380,262 issued ordinary shares of the Company excluding treasury shares.
